MINUTES OF REGULAR MEETING**

Council President Karyl Rice called the meeting to order. Willard Payne led the invocation.

Karyl Rice asked that the record show all members of the council present.

Rosemary Metcalf moved to waive the oral reading of the October 2, 2006 minutes and approve as presented. Willard Payne seconded the motion. Karyl Rice asked for a vote on the motion to approve; on voice vote the motion passed unanimously.

Willard Payne moved to approve the resolution as presented, and Rosemary Metcalf seconded the motion. Karyl Rice asked for a vote on the motion to approve; on voice vote the motion passed 3-0 as recorded by the clerk.
